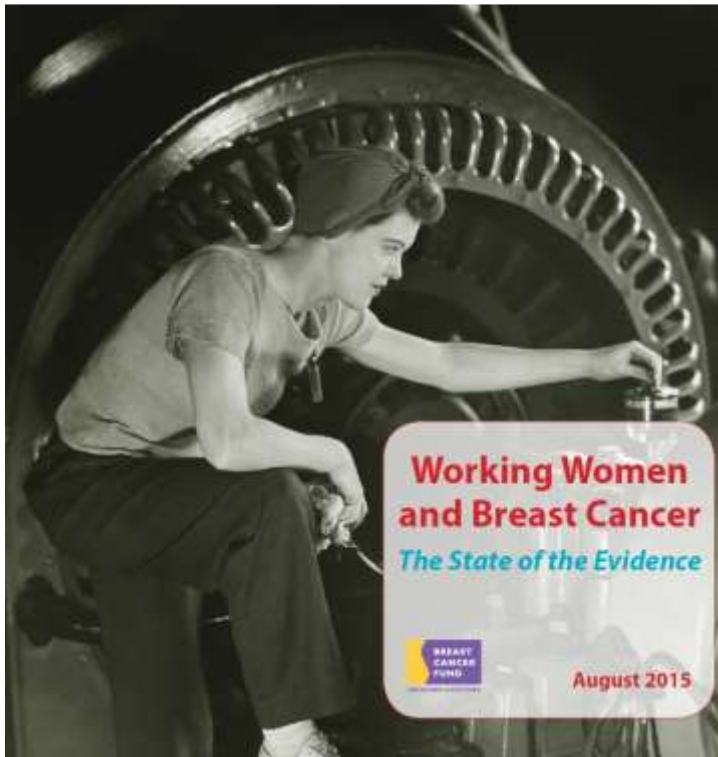

Failure of OSHA



5 types of jobs with elevated breast cancer risk!



Nurses: Up to 50% higher risk than for the general population



Teachers: Up to double the risk



Librarians, lawyers, journalists and other professions: Up to 4 times higher risk



Radiological Technicians: Up to double the risk



Lab Technicians, factory workers and others who work with chemical solvents: Up to 3 times higher risk

Toxic Chemicals

- Formaldehyde
- Dibutyl Phthalate
- Coal Tar

Health Impacts:

- Cancer
- Birth Defects
- Reproductive Problems
- Learning Disabilities



Personal Care Products Safety Act

Good:

- Register Companies and Products
- Ingredient Disclosure for Salon Products
- Review 5 Chemicals/Year

Improve:

- Stronger Safety Standard
- Ingredient Disclosure for Fragrance
- Adverse Event Reporting

Failure of EPA and TSCA

By the Numbers

- **85,000 chemicals**
- **62,000 grandfathered**
- **200 chemicals tested**
- **39 years without updating**
- **5 chemicals regulated**



Elements of True TSCA Reform

- Strong Safety Standard that includes Vulnerable Populations
- Adequate Safety Data on All Chemicals
- Quick Action on the Worst Chemicals, PBTs
- Public Access to Information
- **Protection of States' Right to Act**



Frank R. Lautenberg Chemical Safety for the 21st Century Act

- Pre-**empts Alaska's Ability to Protect Their Citizens**
- Does Not Address PBTs – Persistent Bioaccumulative Toxics
- Too Few Chemicals/Too Little \$\$
- Low Priority – **“Likely” to be Safe**
